### **Change of Premises of the Institution**

WHEREAS, In terms of Section 14/15 of the NCTE Act, 1993, Swami Vivekananda College of Education for Women, 20, Riverside Road, P.O.-Barrackpore, Dist.-North 24 Parganas, West Bengal-700120 was granted recognition *vide* Order No. ERC/7-76.6(II).1/2007/8181 dated 24.05.2007 followed by the Revised Recognition Order *vide* Order No. ERC/NCTE/(ERCAPP1332)/B.Ed.(Revised Order)/ 2015/32140 date 26.05.2015 for B.Ed. Course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-2016.

2. AND WHEREAS, the institution has submitted application for shifting premises dated 03.03.2025 which has been received in ERC office on 11.03.2025 & 02.04.2025. The matter was placed before 367<sup>th</sup> meeting of ERC held on 04.06.2025 and the committee decided as under:

#### "Decision of ERC:

The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -

- The institution has submitted an application for shifting of the premises.
- The institution has submitted a copy of certified registered private lease deed executed on 18.02.2021 issued by the Additional District Sub-Registrar, Sodepur, North-24 Parganas, which is not acceptable as per NCTE Regulations amended from time to time.

After carefully observing the relevant documents, the committee decided to reject the application of the institution for shifting of its premises."

- 3. Accordingly, a letter dated 03.07.2025 was issued to the institution.
- **4. AND WHEREAS**, the institution has submitted a letter dated 22.07.2025 for reconsideration on decision on 367<sup>th</sup> Meeting. The matter was placed before ERC in its 372th Meeting held on 31<sup>st</sup> July 2025 and the committee decided as under:-

#### **Decision of ERC**

The online file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, SOP, representation form of the institution, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee decided that the institution may be asked to apply afresh for shifting of premises.

5. Accordingly, a letter dated 06.08.2025 was issued to the institution.

**6. AND WHEREAS,** the institution has submitted a fresh application alongwith processing fee of the shifting premises vide letter dated 08.08.2025 which is received in the office of ERC-NCTE on 11.08.2025. The matter was placed before 374<sup>th</sup> meeting of ERC held on 25<sup>th</sup> -26<sup>th</sup> August, 2025 and the committee decided as under:

#### "Decision of ERC

The online file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee. Accordingly, the Committee decided that VT be constituted in order to ascertain and scrutinize all the essential documents such as land documents, building plan, CLU, BCC, Non-Encumbrance Certificate along with other required documents in original and verify its authenticity with reference to NCTE Regulations 2014 and mention the status/position of these documents along with deficiencies, if any.

In addition, the VT shall also verify the infrastructure and instructional facilities created by the institution so as to assess its preparedness for running the course as per NCTE Regulations 2014."

- **7. Accordingly**, as per the decision of ERC, inspection of the institution was conducted on 25.09.2025.
- **8. AND WHEREAS**, the VT report of the institution was received on 25.09.2025 and the matter was placed before 379<sup>th</sup> meeting of ERC held on 30<sup>th</sup> September 2025 and the committee decided as under:

#### **Decision of ERC:**

The original file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following:

• As per decision of ERC, Inspection was made.

After carefully observing the online application form, VT report along with other related documents, the ERC found the following:

- 1. The institution has no sufficient furnished laboratory facilities.
- 2. The institution has only 11 computers and one laptop against
- 3. The firefighting system has not been extended to all the buildings of the Institution.
- 4. Toilet facilities are not fitted up to mark for the Physically Challenged candidates.

Hence, the committee decided that the show cause notice be issued to the institution to submit the reply through the portal on the deficiencies mentioned above within 07 days from the date of issue of the show cause notice.

- 9. AND WHEREAS, the institution has submitted reply dated 18.10.2025 received in ERC office on 22.10.2025 on the basis of the minutes of 379<sup>th</sup> meeting of ERC 14<sup>th</sup> October 2025.
- 10. AND WHEREAS, the matter was considered by ERC in its 381<sup>th</sup> meeting of ERC held on 03<sup>rd</sup> & 4<sup>th</sup> November, 2025 and the committee decided as under:-

#### **Decision of ERC:**

"The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, Appeal Order passed by the NCTE-HQ, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -

- Shifting of premises of Swami Vivekanand College of Education for Women from 20, Riverside Road, P.O.-Barrackpore, Dist.-North 24 Parganas, West Bengal-700120 (old) to 3, B.T. Road, Agarpara, P.S. Khardah, North 24 Parganas, West Bengal 700058 (new) is permitted."
- 11. NOW THEREFORE, in terms of above decision of ERC, shifting of institution namely Swami Vivekanand College of Education for Women from 20, Riverside Road, P.O.-Barrackpore, Dist.-North 24 Parganas, West Bengal-700120 (old) to 3, B.T. Road, Agarpara, P.S. Khardah, North 24 Parganas, West Bengal 700058 (new) is permitted."
